## STALLION SERVICE CONTRACT:

### JHT CHEMISTRY

JHT CHEMISTRY is available via AI only. (chilled, fresh and frozen semen)

This contract is made by and between JHT Equine Ltd ("Stud farm") and .....  
("Mare Owner") being the person responsible for the Mare – (owned or leased).

NOTE: The Mare Owner may not substitute another mare for breeding without prior consent of JHT Equine Ltd.

2. FEES: The Mare Owner agrees to pay JHT Equine Ltd the following fees: \$200 booking fee which secures your mares place in JHT CHEMISTRY'S books and the balance of \$1700 + GST + collection fee is payable at least two weeks in advance before you require semen for your mare. (Total Service \$1900 + GST and collection fees)

If the mare fails to conceive on the first insemination then the Mare Owner will be charged a collection fee of \$250.00 (approx) plus GST which needs to be paid DIRECT to JHT Equine , there will be additional costs associated with flights, delivery charges for each subsequent cycle/insemination the Mare is bred on, which need to be paid to JHT Equine before the semen is sent. Delivery charges will apply where semen is to be sent overseas this is to be discussed if the need arises.

3. RESERVATIONS FOR SEMEN: Upon receipt of the Service Fee we will confirm a reservation in JHT Equine Stud book.

It is the Mare Owner's responsibility to check semen availability in advance. We would appreciate a few days notice if possible that you intend to breed your mare or are booking scan dates with your vet. Closer to the date you intend

to breed your mare we suggest you phone or email as we require information from mare owners to enable us to courier semen around NZ.

Early morning scans are ideal as you then have time to organize semen delivery should your mare surprise you and be ready for insemination that day. We need 24 hours notice to guarantee delivery of semen when requested. Any less than this and we do not guarantee we will be able to meet the requested delivery.

NOTE: JHT Equine do not do stallion collections on the weekend, so you will need to time your mare for insemination during the week.

4. SERVICE CONDITIONS / LIVE FOAL GUARANTEE: The Mare will be limited to being bred on four cycles in any one breeding season.

If the Mare fails to get in foal she may return the following season. The collection / delivery costs as above will apply.

If the Mare tests positive for pregnancy but becomes barren during gestation, she will be eligible for a return service. A veterinary certificate of barrenness must be sent to JHT Equine Ltd within 10 days of the examination.

If the Mare produces a live foal that is unable to stand or suckle and it subsequently dies (within 48 hours), the Mare is eligible for a return service. A veterinary certificate must be provided to JHT Equine Ltd within 10 days of the foal's death. It must also state that the mare was properly cared for during gestation and was attended at foaling. Failure to provide this certificate within the given period will make return of service policy null and void.

If the Mare becomes un-breedable for any reason, the Mare Owner may swap the return service to another mare after gaining the permission of the JHT Equine Ltd but NO refunds will be given.

All rights of return to the Stallion do not include, collection and transportation fees and grazing if we are arranging on your behalf.

5. GELDING POLICY: To ensure quality and purity of bloodlines are maintained, all colts born sired by JHT Equine Stallions must be gelded prior to 30 months of age and must not serve any mares during their lifetime. If the colt foal has been sold in-utero or after birth, it remains the responsibility of the signatory of this contract to ensure the new owner is aware of this policy.

6. REFUND OF FEES: The Mare Owner will be entitled to a refund of the Service Fee only if the Stallion dies or becomes Un-fit for service prior to serving the mare in the present breeding season (less the booking fee and our collection costs if any). However we will not re-fund any costs associated with insemination, vet, courier etc. There will be no refunds (except as above) but the mare owner is entitled to sell the breeding contract to another mare owner should they not require it anymore.

7. TRANSFER OF CONTRACT: This contract will not be valid if the Mare is sold or otherwise changes ownership, unless prior permission is gained from JHT Equine Ltd.

8. WARRANTY: The Mare Owner hereby releases JHT Equine Ltd from any responsibility or liability for any disease, injury or accident to the mare or resulting foal from this breeding.

9. ISSUE OF BREEDING CERTIFICATE: Only one Breeding Certificate will be issued for this contract. This will pertain to the Mare described in the contract.

10. LOST OR DELAYED SEMEN. JHT Equine Ltd will not be liable for any costs associated with lost or delayed semen or the mare owners vet fees.
